Full breakdown of results

The satisfaction scores in the table below were submitted to the Regulator of Social Housing in June 2026. They breakdown the responses we received from our low cost rental accommodation, and low cost home ownership. Because we report our performance separately for customers in rented homes and home ownership customers, there are no combined scores in the table below.
